UDIN

Unique Document Identification Number

What is UDIN?

It consists of 18 digit number which is generated for every document to be attested by a Practising Chartered Accountant.

This is to prevent forged signs of CA and misrepresentation of certificates by third parties as attested by CA.

Who can generate UDIN?

Full time practising CA who in case is the signing person.

When to generate UDIN?

It has to be generated at the time of signing the certificate or within 15 days of signing the certificate i.e. date mentioned in the certificate

Does it require any Documents to be uploaded?

No documents are required to be uploaded.

What are Certificates under UDIN?

Certificates means where the financial information is certified as true and correct.

It includes:

- o Net worth certificate for
- 1. Bank Finance,
- 2. Bank Guarantee,
- 3. Educational Loan
- 4. Issuance Of Visa By Foreign Embassy
- o Turnover certificate
- o Foreign remittance outside India in form 15CB
- o Working capital
- o On the basis of Statutory records under Companies Act 2013
- Fair valuation of shares in case of merger / demerger, Buy Back, Allotment of further shares and transfer of shares from resident to nonresident.
- o Liquid asset under 45IB of RBI Act
- o Utilisation of funds/Grants:
- 1. FEMA Act
- 2. Charitable Institutions
- 3. NGO
- 4. Statutory Authority

- o Claim of refund under Indirect Taxes
- Certificates issued by Statutory auditors of Banks and Insurance companies
- Certificate of Short Sale of securities issued by Concurrent Auditors of Treasury Department of Banks
- Certificate of physical verification of securities issued by Concurrent Auditors of Treasury Department of Banks
- Certificate issued for KYC purpose to banks confirming sole proprietorship
- o Certificate Regarding Sources of Income
- Certificates for Claiming Deductions and Exemptions under various Rules and Regulations
- o Certificates issued under LLP Act
- o RBI Statutory Auditor Certificate for NBFCs
- o Certificate issued under RERA
- o Others

Non applicability of UDIN:

This is not an exhaustive list.

- o Auditor's Opinion/Reports issued by the Practicing Chartered Accountant under any Statute w.r.t. any entity or any person (e.g.: Tax Audit, Transfer Price Audit, VAT Audit, GST Audit, Company Audit, Trust Audit, Society Audit, etc.,
- o Valuation Reports,
- o Quarterly Review Reports,
- o Limited Review Report
- o Information System Audit,
- o Forensic Audit,
- o Revenue / Credit / Stock Audit,
- o Borrower Monitoring Assignments,
- o Concurrent / Internal Audit and the like,
- Any report of what so ever nature issued including Transfer Price Study Report, Viability Study Report, Diligence Report, Due Diligence Report, Management Report, etc.

Is UDIN applicable for duplicate copies of certificates already issued?

UDIN it to be generated only for the original certificate and not for the duplicate one issued at the request of the client

Security

It is takes into account the concept of confidentiality as it can viewed only by the members.

Where should the UDIN be mentioned?

In case of manual certificate ,the 18 digit number has to be mentioned in the certificate after every signature and membership number of the CA and in case of digitally signed certificate the UDIN has to be retained for providing the same on being asked by third party

Revocation of UDIN:

The UDIN once generated can be revoked or cancelled with narration. After revocation of the UDIN, anybody searches for that UDIN, appropriate narration indicated by Member with the date of revocation will be displayed for that revoked UDIN.

UDIN in case of Multiple reports for a single assignment:

Same UDIN is to be used for the multiple certificates for a single assignment.

How to share UDIN to third parties consisting of banks / Authorities?

The concerned authorites have to provide the following details

Name of the Authority, Mobile Number and Email of the person searching the UDIN.

However they are not required to register themselves on the UDIN Portal.

Registration procedure:

Steps Particulars

- Click Member Registration or First time
 Sign Up
- 2 Enter Memebrship No, Date of Birth, Year of enrolment
- 3 OTP will be sent to registered mobile Number and Mail ID
- 4 On confirmation of OTP username and Password will be generated



Procedure for generation of UDIN:

On logging into the portal using the above generated user ID and password


- o Select Document type from the drop down menu.
- o Enter Date of Signing Document i.e. the date of signing/certifying the document.
- Enter Financial Figures i.e. any Financial Figures from the document such as Turnover/Net Worth etc.
- o Enter the Description of the Figure
- o Two Financial Figures are mandatory out of 3 (three) given fields. In case, there is no Financial Figure in the Certificate, Zero (0) is to be mentioned in Financial Figure and in its Particulars mention "There is no Financial Figure in Certificate".
- o Select Document Description and enter the description/ details about the Certificate
- Click the button "Send OTP". an OTP would be sent to the Registered Mobile and Email of the Member.
- o Enter OTP as received and click "Preview". In Preview details entered for generating the UDIN will be displayed. If there is any change/error in the content, click "Back" button, or else, click "Submit".
- o 18 Digit UDIN will be generated and that UDIN can be used for mentioning on the Certificate for which it has been generated

Non-compliance of UDIN

It will amount to non-adherence of the Council Decision and may attract disciplinary proceedings as per the Second Schedule Part II of The Chartered Accountants Act, 1949.
